FICAC (Federation Internationale des Corps et Associations Consulaires AISBL) is also known as the World Federation of Consuls, it has 98 Consular Corps as Members.

The Federation has its official seat in Brussels and is recognized as a non-for-profit organization (AISBL) by Royal Decree. FICAC abstains from all religious or political activities and from the practice of any discrimination on grounds of race, sex, colour, religion or such other grounds as enumerated in relevant international human rights treaties.

FICAC has been recognized as an NGO by the United Nations in 1993, initially with ROSTER ECOSOC status and since August 2018 with SPECIAL ECOSOC Status.

It is also recognized as an NGO by the Organization of American States (OAS) and by the European Union (EU).

The primary objective and mission of the International Federation of Consular Corps and Associations (FICAC) is global collaboration and unity with a focus on the promotion of peace, education, culture, international trade, economic growth, equality, and inclusivity.
